On behalf of Fold's Board, our colleagues, and residents we are delighted to present our 2023 annual review. We continue to develop and grow our organisation with a focus on addressing the housing and care needs of older people in Ireland.

The delivery of our Strategic Plan is an important driver in developing our services and setting the path for future growth and development. We are therefore delighted to be well on target in meeting the goals that we set ourselves under the plan. There has been a focus on ensuring financial sustainability, evidencing best practice in governance, and improving capability.

We also set ourselves the task of reviewing our older persons care and housing services and we have been working on this throughout 2023 and look forward to sharing the findings and recommendations from this later in 2024. We will set out what we identify as the challenges and opportunities in meeting the housing and care needs of older persons in Ireland and Fold's role in meeting these. Many thanks to our internal and external stakeholders who have contributed to this key piece of work that will influence our next strategic plan.

During 2023 we continued to build a strong development pipeline that saw an increase in the number of homes under construction, and in 2024 we have already had the pleasure of bringing much needed new homes into management.

At Fold we set ourselves ambitious goals regarding standard of services and the financial parameters within which we operate. Our commitment to this is demonstrated in our excellent performance, customer service, and support for colleague learning and development demonstrated in this review. Customer service remains one of our top priorities, so we are delighted to be able to report that 97% of our residents in Housing with Care are satisfied with the service they receive and 95% of residents in our Independent Living and General Needs homes report the same. These continue to be some of the best responses in the sector.

Our biggest challenge throughout the year is one experienced by many organisations in Ireland, the recruitment and retention of qualified and experienced people. We are therefore pleased that our efforts in 2023 to build our employer brand and increase our reach to potential candidates has yielded positive results. We have seen an increase in both quantity and quality of applications and made several successful appointments to our team. This work has continued in early 2024 with the launch of Fold's first People Strategy, an important roadmap for us to achieve our strategic goals to further develop our organisation capability.

2023 was a time of change for the senior leadership team and Board with a new Chair and CEO. Kath Cottier started as CEO in January 2023 and on the resignation of Peter Ayton, Belinda Ó Conaill was appointed Chair. On behalf of Fold, we wish to thank Peter for his commitment to Fold over many years, his stewardship oversaw the separation from Fold's parent company in Northern Ireland and the establishment and development of core services. We also welcomed Marguerite Staunton to our Board of Directors. As we progress our work, we remain excited about the opportunities open to Fold and committed to developing our role as a leader in the development of housing and care solutions for older people. We continue to be mindful of the challenges we face and the requirement to operate efficiently and sustainably to meet the needs of our residents, their communities and our many external partners. In doing this we are grateful for the experience and commitment of our voluntary Board who provide leadership and are advocates for the needs of our residents and colleagues. We also acknowledge the support of our many partners from national and local Government, funders, statutory and voluntary organisations nationally and locally, as well as our many construction and development allies. Finally, we would like to acknowledge the dedication and professionalism of the Fold team. They maintain the trust of our residents and families and the many organisations we partner with and are therefore at the centre of our achievements throughout 2023.

Oversee the development pipeline. Appraising and advising the Board on all new development projects and initiatives.

#### **Nominations & Governance**

Monitor regulation and governance control frameworks. Review the structure, size and composition of the Board.

#### **Capital Requirements**

Monitor, review and evaluate Fold's funding and borrowing capacity to meet development ambitions.

#### **Focus on Tenant Engagement Officers**

Following the launch of our Tenant Engagement (TE) Strategy in 2023, Fold has taken great strides to increase our work in this area. There is a focus by our Tenant Engagement Officers (TEO) on building communities and working one-to-one with tenants to overcome challenges. Our TE service exists to enhance tenants' quality of life by fostering social connections and providing opportunities for personal growth.



### 71 Community Events

Working with tenants we organised regular activities ranging from social gatherings, cultural celebrations, educational workshops and fitness classes.

# 53 One-to-One Support Sessions

This individual support is crucial in helping tenants navigate various challenges from completing paperwork, securing financial assistance, accessing support packages and overcoming social isolation.



#### **Introducing Ben**

Ben lives in St Agnes, Crumlin. When the TEO first met Ben, he felt isolated from friends and family, mostly keeping to himself. During their first meeting, Ben shared his love for music and expressed a desire to learn an instrument to pass the time. Recognising the importance of nurturing this interest, the TEO connected Ben with the CCMA Music Centre in Crumlin where he began guitar lessons. Ben describes this seemingly small step as a turning point in his life, increasing his engagement in many social activities.

The TEO also connected Ben with Irish-speaking classes and other activities and he is now also a regular attendee at events organised by the TE team. On a trip to Howth, Ben had the opportunity to meet other residents from St Agnes and enjoyed the experience so much that he and several of his neighbours went out for dinner together and now continue to meet regularly.

Ben's transformation highlights the profound impact of TE at Fold. He has become an integral part of the community, even volunteering to join Fold's Tenant Group, which includes tenants from across the Fold community beyond St Agnes. Ben expressed his gratitude saying that it is great to know a TEO is only a phone call away, stating that without the support and initiatives provided by TE, he would still feel quite lonely.



#### Focus on Housing with Care

Our Housing with Care (HwC) schemes are subject to regulation by the Health Information and Quality Authority (HIQA), ensuring the highest standards of care and service delivery. At our schemes, we hold ourselves to the highest standards of care, in line with HIQA regulations and each inspection is an opportunity to showcase our commitment to quality and compliance. Our team works diligently to ensure that all regulatory requirements are met and exceeded, reflecting our unwavering dedication to the well-being of our residents.

Whilst we operate a social rather than nursing model of care, we recognise the importance of regulatory oversight

in maintaining quality standards. Compliance reassures our residents, their families and friends, our funders, and the public of our commitment to excellence and providing a safe and nurturing environment for all our residents.

Our Fold care colleagues are the backbone of our HwC schemes, working tirelessly to meet and exceed regulatory requirements and we take great collective pride in our positive inspection outcomes.

HIQA carried out two unannounced visits in 2023 inspecting 28 areas against the regulatory guidelines. Fold was found compliant in 25 areas, and substantially compliant in the remaining 3 areas.

### Quotes from our inspection reports

"The centre was well-resourced. This inspection found that there was a clearly defined management structure in place, with effective management systems ensuring oversight of the service and the delivery of quality care to residents." "Improvements and ongoing refurbishment was taking place in the centre. For example, new seating had been placed in the courtyards, a new clinical hand wash sink had been installed on each floor and a sitting room on the first floor was newly painted with new furniture and two karaoke machines for residents to use."

"Staff who spoke with the inspector were knowledgeable about residents and their needs, responding to safeguarding issues. It was evident that staff knew residents well and observations were that they were responsive to residents' needs."

"Staff confirmed that they felt supported, and that they could raise issues readily with the person in charge. There was a good system of supervision in each of the departments."

"The inspector observed many activities taking place on the day of inspection and could see both residents and staff enjoying each other's company."

Following the project, we are delighted to report increases in both the quantity and quality of applications, with many successful appointments.







#### **Regulatory compliance**

Full regulatory compliance was sustained throughout the year. Fold Housing is registered as an Approved Housing Body (AHB) with the Department of Housing, Local Government and Heritage. We are also registered with the Charities Regulator, and the AHB Regulatory Authority, and have approved borrowing status with the Housing Finance Agency. Our Housing with Care Schemes are also registered with HSE and audited by HIQA.

#### **Internal Audit and Risk Management**

Fold has engaged Mazars as our internal auditors and they continued their programme of audits in 2023. The programme covers key business areas with their findings and recommendations acted upon by management. Responsibility for identifying, evaluating and controlling risks is defined across the business and risk registers are reviewed at each Board meeting as well as the Operations, Development, and Finance, Audit & Risk Committee meetings.
